ONLINE LEARNING MODEL AND ASSISTANCE OF PARENTS AND PRIVATE TEACHERS IN INCREASING STUDENT LEARNING ACHIEVEMENT AT MIMA KH. SHIDDIQ JEMBER

This article discusses the online learning model and the assistance of parents and private teachers in improving student learning achievement at MIMA KH. Siddiq Jember. Online learning is not only due to an epidemic, but the demands of contemporary educational developments which require using online. This research uses qualitative methods and data collection uses observation and interviews. The results of this research show that parents and private teachers play a very active role in improving student achievement because there is close cooperation between the school and parents or private teachers at home. So that it can build a learning environment that can encourage students to be active and really learn, and can also help educate students to catch up on lessons they have missed at school.

INTRODUCTION

Third. Online learning is oriented towards achieving complete learning targets and assignments, so that learning is active and effective to achieve learning goals. Shiddiq allows teachers to use elearning, but there are still no guidelines for using elearning media. This needs to be regulated because of adaptation to advances in educational and learning technology.

RESEARCH METHODS

Research Approach: Research was conducted using a qualitative method approach with a descriptive type. Bogdan and Taylor and Moleong, define qualitative methods as research procedures that produce descriptive data in the form of written or spoken words from people and observable behavior. The location of this research is at MIMA KH Siddiq 01 Jember. This location was chosen because of the attractiveness of the learning model implemented, namely online learning as a need and fulfillment of learning targets.

Presence of the Researcher: One of the characteristics of qualitative research is that the researcher acts as both an instrument and a data collector. Non-human instruments (such as: questionnaires, interview guides, observation guides and so on) can also be used, but their function is limited to supporting the researcher's task as a key instrument. Therefore, in this research, the presence of the researcher is absolute, because the researcher must interact with the environment to collect the data needed for the research. This includes active research.⁵

This data collection method uses (1) observation method, namely the researcher's observation of the problems faced by madrasas so as to produce data about madrasas, pictures, video recordings, learning activities, learning places and madrasa guidelines. (2) using the interview method by interviewing the research informants so that the researcher records what is seen, heard and what is felt according to the existing data held by the institution. (3) using the Documentation method, namely collecting data through manuscripts and documents owned by the Madrasah

Data Analysis, Noeng Muhadjir stated the meaning of data analysis as "an effort to systematically search for and organize notes from observations, interviews, etc. to increase researchers' understanding of the cases studied and present them as findings for others. The data analysis model used by researchers is the Miles, Huberman, and Saldana interactive model. The components in Miles and Huberman's data analysis are First, data condensation. Second, Data Presentation (data display) Third, Drawing Conclusions (Conclusions drawing).

Data Validity: To avoid errors or mistakes in the data that has been collected, it is necessary to check the validity of the data. Checking the validity of the data is based on the criteria for the degree of trust (credibility) using triangulation techniques, diligent observation, peer checking (Moleong).⁶

DISCUSSION

1. Online Learning Model with Help from Parents and Private Teachers

According to Effendi, he explained that online is all activities that use computers and the internet. Darmawan also explained that online is a learning activity that utilizes networks (Internet, LAN, WAN) as a method of delivery, interaction and facilities and is supported by various forms of learning services. According to Romli, the general definition of online is any type or format of media that can only be accessed via the internet, containing text, photos, video and sound, as a means of online communication, while the specific definition of online is interpreted as a medium in the context of mass communication. Based on the

This is in accordance with the opinion of Hidayat K, who states that the best learning model is the one that best suits the characteristics of the students. , objectives, teaching materials, tools/media, available time, situations and conditions.⁸

The online learning model is learning that aims to reach a massive and wide group by utilizing the internet network (Yanti et al). The online learning process utilizes technological advances such as multimedia technology, video, virtual classes, animated online texts, voice messages, email, conference calls, and online video streaming. Online learning can be done massively with an unlimited number of participants, and can be done for free or for a fee (Bilfaqih & Qomarudin).⁹

The offline learning model can be carried out by submitting assignments to school or taking turns studying face-to-face by implementing applicable health protocols (Putri et al). The development of offline learning models can overcome the obstacles complained about in online learning models, but learning cannot be said to be running completely effectively. This is because even though learning uses an offline system, students and teachers still communicate via smartphone because they cannot communicate directly due to the Covid-19 pandemic. So the teachers whose role is to design interesting learning (Akhwani & Nurizka) are actually confused about which learning model is suitable to be applied to students. The success of learning depends on choosing the right learning model (Suprihatiningrum).¹⁰

- 4. Parents ensure that children learn with Parents help children learn safely and effectively, both at school and at home.
- 5. Encourage children to learn online.

Online learning is effective for dealing with learning that allows interaction in virtual classes that can be accessed anywhere and at any time. Online learning can train independence and increase motivation. However, the weakness of online learning is poor supervision during the online learning process. Weak internet signals and high quota fees are challenges for online learning. (Sadikin & Hamidah).¹¹

2. Student Learning Achievement through Online Learning with the Assistance of Parents and Private Teachers

Learning achievement is a sentence consisting of two words, namely achievement and learning, achievement and learning are two words that have different meanings. Therefore, to make it easier to fully understand learning achievement, the following is: Achievement is something that is born or made, held, done, created either individually or in groups to achieve brilliant results obtained through feeling the progress or development of the material presented to them..¹²

Heri Gunawan states that "learning achievement is a learning outcome that can be achieved by individuals after carrying out a series of learning processes. So

Students who are highly motivated in learning are likely to obtain high learning outcomes, meaning that the higher their motivation, the more intensity of effort and effort they make, the higher their learning achievement will be.¹⁴

Learning achievements at MIMA KH Siddiq through online learning with the help of parents and private teachers, among others:

This achievement is in accordance with Subhan Adi Santoso who stated that achievement includes (1) cognitive (reasonable, intelligent). For example, a student is able to mention the subject matter that has been studied last week, then that student can be said to have cognitive potential and so on. (2) Affective achievement (akhlaq) For example, a student can show an attitude of accepting and rejecting a statement or a problem, etc. (3) Psychomotor achievements, namely verbal and non-verbal expression skills, movement and action skills. For example, being polite to parents.¹⁷

3. How to Assess Learning Achievement in the Online Learning Model. Help from parents and private teachers

How to assess online learning at MIMA KH. Siddiq Jember as a result of an interview with Mrs. Siti (21-12-2022) as a parent of a student from Muhammad Haidar Afkar stated that the online learning assessment at MIMA KH Siddiq uses an e-learning application, when e-learning children answer the questions in e-learning automatically The value will appear and can be known directly by students and parents or private teachers. The role of parents and private teachers is to help educate or teach students lessons according to the grid for discussing the material in the student's textbook.

So MIMA KH Siddiq has an learning tool that can be used for online learning and is assisted by parents and private teachers, so that the students' learning results are maximized and they master the subject matter, in the end the students are able to answer correctly and get very satisfying grades.

Ahmad, a parent of student Muhammad Haikal Rabbani, explained that online learning assessments with the help of parents or private teachers have weaknesses, namely that parents and private teachers can help directly answer the questions in elearn using the help of a Hansphone. (Interview, 06-11-2023). Thus, according to Wahid Guru MIMA KH Siddiq, parents should not give answers to their children, but should only provide knowledge related to the subject being tested or the subject assignments (Interview. 07-22-2023)

Meanwhile, to assess students' morals, parents or private teachers use a book relating to student achievements, such as achievement in reading the Koran and

Apart from e-learning learning, we also use the WhatsApp application which can help students in this learning model. WhatsApp itself is used to receive assignments from teachers and collect assignments from teachers so students don't need to be confused about learning and the teacher in one week. use a faceto-face meeting to explain what the teacher taught on WhatsApp and the teacher assesses developments in the online learning model. Using the WhatsApp application is very helpful in implementing online learning during the Covid-19 pandemic, because it is simple and has many features that can make it easier for users to operate compared to other online applications.

Parent-assisted learning can overcome the teacher's assessment of affective aspects and can also help to directly monitor how students act and behave. You can also overcome online learning so that children don't get bored and don't get lazy about studying, because when studying, being assisted by parents in forming better habits will have an influence on students forming good character or personality. Students' habits at home will also influence students' psychomotor aspects. Parents who pay full attention to their children's talents and interests, such as directing their children's skills well and full of support, make their skill achievements good.¹⁸

CONCLUSION

So it can be concluded that How to Assess Learning Achievement in the Online Learning Model. Help from parents and private teachers is done by (1) using the e-learning application that is owned by MIMA KH Siddiq Jember. (2) The

The advantages are (1) the learning assessment model with the help of parents or private teachers means that the assessment of students is more objective and students are actually assessed based on what the students themselves have done, (2) it creates a high awareness for students that learning is behavior that must be carried out continuously and the home environment can be used as learning as in school, (3) parents can monitor their children's development and it is easier for teachers to measure their students' development. (4) Parentassisted learning can overcome the teacher's assessment of affective aspects and can also help to directly monitor how students act and behave. You can also handle online learning so that children don't get bored and don't get lazy about learning,
