MANAGEMENT STRATEGY FOR ISLAMIC EDUCATION INSTITUTIONS IN IMPROVING DISCIPLINE CHARACTER

ABSTRACT

Discipline is obedience to respect and implement a system that requires people to comply with decisions, orders, and regulations that apply. Islam teaches us to pay attention to and use disciplinary values in everyday life to build better community life. This study aims to determine the discipline techniques and strategies of SD Al-Furgon Jember students. The high level of student discipline is due to the high motivation of teachers towards students about the importance of discipline. In addition, sanctions against students who do not comply with the rules are also a motivating factor for students always to instill discipline. The research method used is a descriptive qualitative method and collects data using the form of observation, interviews, and documentation. The study results showed that (1) the disciplinary techniques of SD A-Furgon students were excellent, and they had to continue to improve the discipline of students (2) the strategy of SD AL-Furgon teachers in improving student learning discipline used a Personal Approach, Group Approach such as advising if it is too late in the prayer congregation, and Character and Moral Guidance.

INTRODUCTION

Education is a process with specific methods so that a person gains knowledge, understanding, and ways of behaving according to needs. (Muhibbin Shah, 2010). As explained, Education, according to the Law on the National Education System of 2003, is A conscious and planned effort to create a learning atmosphere and learning process so that students actively develop their potential to have spiritual, and spiritual strength, self-control, personality, intelligence, noble character, and skills needed by himself, society, nation, and state.

Education in schools is not only learning material but education in schools is essentially fostering the attitude and soul of each student. Students, as the next generation of the nation, must be introduced from an early age to values and norms, such as rules, discipline, policies, and regulations that must be obeyed, and sanctions for violating these rules.

Efforts to improve student discipline need to be carried out by all components of the school through programs organized by the school in a programmed or incidental manner. The SD school facilities can be considered to be of very high quality, not only in learning and extracurricular activities but also regarding the discipline of the students and the teacher. The Al-furqon Elementary School learning system uses holistic learning, combining affective, cognitive, and applicable aspects of the latest developments in information and technology. The SD instills the Qur'an's values of faith and love in its students. This is very influential in changing students' mindset and behavior habits, especially nowadays, many children are influenced by gadgets and need to apply them properly.

Regarding discipline, Al-Furqon Elementary School is very consistent in managing the discipline of students from the start until the KBM takes place outside the classroom and after school. This discipline applies to students, staff, and Al-furqon Elementary School teachers. As with the Koran activities in the morning, teachers who do not have picket duties must attend halaqah reciting the Qur'an.

In class management discipline for grades 1 to 3, they are still directed by the homeroom teacher because they still don't understand how to discipline class properly. Students in grades 4 to 6 have been taught how to manage class discipline properly and are assisted by the homeroom teacher of each class. Apart from that, SD Al-Furqon also differentiates male and female classes for students in grades 4 to 6 because they want to teach students about puberty and maintain an association with the same sex.

Al-Furqon Elementary School uses the Disciplinary Technique to understand each student's character; they also don't give violence when students commit violations. Al-Furqon Elementary School teachers educate their students to have good morals towards them and instill discipline. The high level of student discipline is due to teachers' high motivation towards students about the importance of discipline. In

In instilling discipline in students, teachers as educators must be responsible for directing what is good, patient, and understanding. Teachers must be able to cultivate self-discipline in students, especially self-discipline. For this purpose, the teacher must be able to do the following things (Mulyasa, 2006):

- a Helping students develop patterns of behavior in themselves
- b Help students improve the standard of behavior
- c Using implementing school rules as a tool to enforce discipline

The following is data from observations, interviews, and documentation. The results of data collection about educational institutions in improving the discipline of participants in SD AL-Furqan Kaliwates Jember are:

a Personal approach

The study results show that the student delay rate is meager. This is because some students still need to arrive on time every day. Student tardiness does not mean without cause; various reasons are expressed by students who are often late, including traffic jams on the way, punctured bicycle tires, staying up late at night, and so on.

Every student who is late or exceeds the time at 6.45 will be punished by being locked outside the fence until the class bell starts when the subject begins. Then, they will get a warning or direction from their teacher; if they are late for the second time, the teacher will contact both parents to notify their child's problems. Those who are late for the third time will receive

sanctions from the guidance and counseling teacher, such as cleaning the field and sweeping the mosque's courtyard, their names will be recorded in the student's late absences, and so on. If they are repeatedly late, their parents will call them.

Based on the results of the interviews, it can be understood that the teacher's strategy in improving student learning discipline uses an individual approach by giving advice and guidance and conducting active communication with parents of students if the student repeatedly makes mistakes and takes the 'iqob approach by giving sanctions according to the mistakes he has made.

b Group Approach

Based on the results of the study, it was stated that according to the vice principal, students who do not pray would be advised in the form of telling stories about threats to people who do not pray or giving lectures so that students can open their hearts to pray at any time. As for students who do not recite the Yasin together, the teacher looks at them with sharp eyes at the students, so they want to reread it. The approach is an advisory and active communication approach so that students can open their hearts to pray on time.

c Character and Moral Guidance

Character is an element of personality in terms of ethics or morals. Character refers to a series of attitudes, behaviors, motivations, and skills as a manifestation of the value of human moral integrity in the face of adversity. Based on the interview results, Ms. Entis said that if a student steals, they will be given advice using an individual approach and calling the teacher's office personally. Then if there are dishonest students, the teacher asks why they are dishonest and why they are fraudulent. There it can be understood that the teacher uses an active communication

approach with students so that they are always honest in their actions. After getting the answer advised him that being honest is very important in everyday life. Making a fuss is also one of the destructive attitudes/morals, so if a student makes a fuss, the teacher will approach him to ask what he understands from the explanation earlier. Then the teacher uses an exemplary approach for students who make noise in class when the teacher is teaching. This is by the results of observations in the field that the interviews above have answered questions that differ from the desired results.

CONCLUSION

Discipline is obedience to respect and implement a system that requires people to comply with decisions, orders, and regulations that apply. Islam teaches us to pay attention to and use disciplinary values in everyday life to build better community life.
